ABOUT THIS CERTIFICATE: Handicaps imprinted on the other side of this page are issued based upon information you as the boat owner(s) supplied to the Lake Michigan Performance Handicap Racing Fleet Council of Handicappers. The Council's assessment of the boat's speed potential, reflected in its base handicap [BHCP], also considers publicly available data for the boat's class or type. *Both sides of this certificate should be duplicated to create copies for submittal with race entry forms. Retain this original document with the dated signature(s) of the owner(s) in a safe place.*

REPLACING A LOST OR MISPLACED CERTIFICATE: Duplication of a lost or misplaced certificate is time consuming and costly. The fee for a duplicate certificate is **\$35.00** and must accompany a written request for replacement of the original certificate. *The replacement certificate will be mailed only to the owner. It will not be sent by FAX or email to anyone else or any organization.*

STABILITY OF HANDICAPS: In all but a very few cases, an issued handicap is stable and does not change during the season unless one of the following circumstances occurs: the LMPHRF Council of Handicappers receives new information correcting hull, rig, and sail dimensions, the Council receives additional race data for new boats assigned a provisional handicap, or a USPHRF appeal of a LMPHRF determined handicap is implemented. *The Lake Michigan Performance Handicap Racing Fleet Council of Handicappers will not knowingly continue the validity of a handicap certificate issued in error.*

WAIVER, RELEASE, AND COVENANT NOT TO SUE: By dated signature(s) below, I(we) acknowledge that all of the activities of Lake Michigan Performance Handicap, Inc., (herein and hereafter designated LMPHRF) Council of Handicappers are undertaken by volunteers using their own time and funds for their efforts in consideration and assignment of the handicap for the boat specified on the reverse side of this certificate. I(we) hereby *waive, release, and cancel any and all claims I(we) may have against LMPHRF, its officers, directors, trustees, and committee members, measurers, agents, and representatives arising out of the functions and activities of LMPHRF and actions of persons fulfilling the referenced offices and positions.* I(we) do further covenant and agree not to sue or bring claim of any nature whatsoever against LMPHRF and all other persons acting on behalf of LMPHRF relating to any performance of LMPHRF functions and activities.
